AND DIRECTING STAFF TO FILE A RECOMMENDATION**

On May 27, 2022, Big River Broadband, LLC d/b/a Circle Fiber (Circle Fiber), filed its application for designation as an Eligible Telecommunications Carrier in parts of Cape Girardeau and Butler Counties. The Commission will direct its Data Center to issue notice of the application, set a deadline for requests to intervene, and direct the Staff of the Commission to file a recommendation.

THE COMMISSION ORDERS THAT:

1. The Commission’s Data Center shall send notice of this application to all local exchange carriers certificated to provide service in Missouri.
2. Requests to intervene shall be filed with the Commission no later than June 14, 2022.
3. The Staff of the Commission shall file a recommendation no later than June 30, 2022.

4. This order shall be effective when issued.
