On May 25, 2017, Callabyte Technology, LLC (Callabyte) notified the Commission that the company no longer wished to be registered as an IVoIP provider in Missouri.

On October 7, 2015, the Commission granted Callabyte registration to provide IVoIP services in the State of Missouri in File Number DA-2016-0073.


The Commission will direct its Staff to review the request and file a recommendation regarding the cancellation of Callabyte's IVoIP registration.
