ORDER CANCELING IVOIP REGISTRATION

Issue Date: July 6, 2021

Effective Date: August 5, 2021

On June 17, 2021, the Commission's Staff filed a recommendation asking the Commission to cancel the IVolP registration of Carousel Industries of North America, Inc. (Carousel). The Commission granted Carousel that registration in File No. DA-2021-0140, on November 17, 2020.

Staff explains that Carousel sent a letter to Staff on June 14, 2021, indicating it does not serve any customers in Missouri and requesting its registration be canceled. Staff indicates Carousel's request to cancel its registration is in compliance with Commission rule 20 CSR 4240-28.011(3), and asks the Commission to cancel that registration.

On June 21, 2021, the Commission issued an order allowing parties until July 1, 2021, to object or to request a hearing. No objections or requests for a hearing were filed.

The Commission has the authority to cancel a registration pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on the company's request, and Staff's motion, the Commission finds that the registration granted to Carousel shall be canceled.

THE COMMISSION ORDERS THAT:

1. The registration to provide IVoIP services granted to Carousel in File Number DA-2021-0140, is canceled.
2. This order shall become effective on August 5, 2021.
3. This file may be closed on August 6, 2021.
