ORDER CANCELING IVOIP REGISTRATION

Issue Date: January 17, 2023

Effective Date: February 16, 2023

On December 30, 2022, the Commission's Staff filed a motion asking the Commission to cancel the IVoIP registration of Small Office Systems, Inc. d/b/a SOSPhones.com (SOSPhones). The Commission granted SOSPhones that registration in File No. DA-2015-0243, effective on April 20, 2015.

Staff explains that SOSPhones notified the Commission that it no longer wants to retain its registration and asks that the Commission cancel its registration. Staff indicates SOSPhones' request to cancel its registration complies with Commission Rule 20 CSR 4240-28.011(3), and asks the Commission to cancel that registration. Staff indicates SOSPhones does not have a currently effective tariff.

On January 3, 2023, the Commission issued an order allowing parties until January 13, 2023, to object or to request a hearing. No objections or requests for a hearing were filed.

The Commission has the authority to cancel a registration pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on the company's request, and Staff's motion, the Commission finds that the registration granted to SOSPhones shall be canceled.

THE COMMISSION ORDERS THAT:

1. The registration to provide IVolP services granted to SOSPhones in File Number DA-2015-0243, is canceled.
2. This order shall become effective on February 16, 2023.
3. This file may be closed on February 17, 2023.
