Come now, Mr. Craig Mershon with a proposed procedural schedule that would meet his reasonable accommodations and give him time to prepare for the evidentiary hearing that will be taking place in the very near future. There was a pre-hearing scheduled for November 13, 2013 to discuss the unfair treatment which still exist between the opposing counsel and Mr. Mershon. 
Evidentiary Hearing should be on January 16, 2014 or close to that time.
