RENEWED OBJECTION OF TWO MOTIONS ISSUED BY THE REGULATORY JUDGE AND UNFAIR TREATMENT BY THE REGULATORY JUDGE

Comes now Mr. Craig Mershon stating that he objects to the Regulatory Judges denial of his two motions.

First, Mr. Mershon requested extra time to prepare his pleadings because of his disability cerebral palsy. Mr. Mershon is legally blind. His visual acuity is 2200/20 in his right eye and 2100/20 in his left eye. He has limited motion in his right hand because of his cerebral palsy. He has very limited use of his left hand.

Since Mr. Mershon's software Dragon Naturally Speaking is non-operational at this time Mr. Mershon must type with one finger until his software is operational again. Even if his software is operational it would take Mr. Mershon a little longer than normal to type and prepare pleadings.

Furthermore, Ameren Missouri has been very harsh towards Mr. Mershon for quite some time. They have been harsh towards him since he has had to pay for service since 1987.

Today October 1, 2013 Mr. Mershon spoke to the Regulatory Judge and he too was very harsh towards Mr. Mershon. In a previous pleading Mr. Mershon requested that his pre hearing conference be held on a date when his representatives could be present. His representative chose October 9, 2013 or October 16, 2013 at 1:00 pm. Mr. Mershon would request a telephone conference hearing since traveling would be difficult do to the distance he would have to travel for a pre conference hearing.

When Mr. Mershon asked the Regulatory Judge to read his Order he refused and was very harsh about the refusal. He indicated that Mr. Mershon could go on a certain website to read the Order. Mr. Mershon told the Judge he could not see well enough to access that website. The Judge replied "that is what you must do in order to see my Order or wait until you get it in the mail. I want a reply by October 11, 2013." Mr. Mershon told the Judge he would probably need extra time to reply to the pleading depending on when he received it.

Mr. Mershon is preparing to file a case with the Federal District Court of Eastern Missouri if he cannot get satisfaction from this opened case.

If he does not get the things he is requesting he believes that his 14th Amendment Rights under the US Constitution have been violated as well as his rights under the Americans with Disabilities Acts 1990 Title II.

Therefore because of these circumstances listed above Mr. Mershon is requesting a new date for his pre conference hearing. He renews his objections for the denial for extra time to file his pleadings and the objection to the cruel treatment by the Ameren Missouri Customer Service Department, the Missouri Public Service Commissions Customer Service Department as well as the Regulatory Judge.
