**Complainant Michele Westmoreland's
Compliance with the Commission's "*Fourth Order Extending Time*"
And Motion to Participate in the Pre Hearing Conference By Telephone**

Comes now Complainant Michele Westmoreland and for her compliance with the Commission's "*Fourth Order Extending Time*," states as follows:

1. Complainant Michele Westmoreland seeks recompense from Missouri American Water Co. and its insurer, Travelers Insurance Co., for water damage to her home in St. Louis County, MO, sustained on or about December 3, 2013.

2. In its Order dated June 24, 2015, the MO Public Service Commission granted Complainant's Fourth Motion for Additional Time, awarding 60 more days or until August 25, 2015 for the parties to try to resolve their differences or otherwise to file proposed dates for a Pre-Hearing Conference.

3. The parties have not been able to resolve the matter. Beginning Monday, September 21, 2015 through Friday, October 30, 2015 Complainant Michele Westmoreland and her counsel can be available for a Pre-Hearing Conference every day and time except:

- a. Tuesday, September 22, 2015.
- b. Wednesday, September 23, 2015.

4. Because this Conference is meant to attend to scheduling details, and not the merits of the claim, Complainant respectfully requests that she and her counsel be permitted to participate by telephone. If this request is granted, Complainant and her counsel respectfully request that the Commission provide telephone log in and participation information at its earliest convenience to Complainant and her counsel.

WHEREFORE, Complainant Michele Westmoreland moves for an Order scheduling a Pre-Hearing Conference between the dates of September 21, 2015 and October 30, 2015, except on the exclusionary dates shown above, that Complainant and her counsel be permitted to participate by telephone and that the Commission provide telephone log in instructions to Complainant and her counsel at the Commission's earliest convenience and for such other and further relief as be meet and proper in the premises.
