**SECOND SUPPLEMENT TO APPLICATION**  
**FOR DESIGNATION AS AN ELIGIBLE TELECOMMUNICATIONS CARRIER**

COMES NOW Budget PrePay, Inc. (“Budget PrePay”), pursuant to 4 CSR 240-2.080 and for its [Corrected](#) Second Supplement to Application for Designation as an Eligible Telecommunications Carrier states as follows:

1. Budget Prepay needs to make two corrections to the Application and prior Supplement.
2. First, Budget Prepay does intend to offer optional MCA service, at an additional monthly charge of \$20.00.
3. Second, the Deluxe service package does not include 3-way calling or call forwarding, and the monthly rate will be ~~\$33.45~~ [33.95](#) plus \$9.95 for unlimited (2000 minutes) long distance for a total of \$43.40.

WHEREFORE, Budget PrePay requests that the Commission grant its application and designate it as an ETC for the Designated Service Area, and grant the waivers requested herein.
