- 1. On page W-2 and S-2, the No. of Customers at Beginning of Year (Column b) does not match the 2017 Annual Report No of Customers at End of Year (Column c). Please check the data provided and correct any errors.
- 2. On page W-4, lines 15 and 16 (November and December) gallons pumped were zero. Please check the data provided and correct any errors.
- 3. The Depreciation Rates listed on page W-5, Column (J), do not reflect the rates authorized by the Commission for your company. Please check this data and make any necessary changes. If you have questions regarding your rates, please contact me to discuss.
- 4. On page W-5 and S-5, Depreciation Expense was not calculated.
- 5. On page W-6 (pt 2), Annual Cost (line 10) and Annual Quantity (line 11) was not completed.
- 6. On page W-8, Service Connections Available for Use was not completed. For the 2017 Annual Report, the Total No. at End of Year was 89 however for the 2018 Annual Report Total No. at Beginning of Year (column B) it is 0.
- 7. On page S-2, the No. of Gallons Sold (column d) is not filled in.
- 8. There were 2 pages of S-2 with different information submitted. Please submit the correct page.
- 9. The Depreciation Rates listed on page S-4, Column (J), do not reflect the rates authorized by the Commission for your company. Please check this data and make any necessary changes. If you have questions regarding your rates, please contact me to discuss.
- 10. On page S-5, Date of Haul for sludge was not completed.
- 11. The Name of Affiant and Official Title of the Affiant was omitted from the Verification page. The Verification page must be complete in full.

A response for this/these item(s) is <u>required</u> in order to show your report as complete and remove it from deficiency status.

You **must resubmit** the Annual Report, in its entirety, with the appropriate changes and the referenced identification number below for it to be properly entered into the system. <u>An updated Verification page attesting to the new/updated information is also required</u>. A response to this deficiency is due by June 25, 2019.

Your prompt attention to resolving this matter is appreciated. The Commission's rule 4 CSR 240-10.145 (Electric, Steam-Heat, Gas, Water/Sewer), and 4 CSR 240-28.040 (Telecommunications) states that a utility company which receives a notice of deficiency, for the information provided in the Annual Report, shall respond to that notice within **20 days** or the utility company is subject to a **penalty of \$100** for each day that it is late in filing its response to the deficiency.
