**MOTION TO EXTEND THE DEADLINE FOR FILING A  
PROPOSED PROCEDURAL SCHEDULE**

COMES NOW the Office of the Public Counsel and for its Motion to Extend the Deadline for Filing a Proposed Procedural Schedule states as follows:

1. On December 22, 2010, the Commission issued an order in which it directed the parties to jointly or severally file a proposed procedural schedule no later than January 12, 2011. Due to a number of other pressing matters, the parties have not yet discussed a procedural schedule for this case. The parties to this case are all involved in the hearings in Case Nos. ER-2010-0355 and ER-2010-0356 beginning January 18, and plan to make time to meet during the course of the hearings to discuss the appropriate schedule for this case.

2. To allow the parties to discuss the appropriate procedural schedule, Public Counsel requests that the Commission extend the deadline from January 12 to January 21. Public Counsel has conferred with all the parties and all support this request.

WHEREFORE Public Counsel respectfully requests that the Commission extend the deadline for filing a jointly proposed procedural schedule or for filing separately proposed procedural schedules from January 12 to January 21.
