- 1. On November 1, 2006, Aurora Communications (Applicant) filed its application for a certificate of service authority and competitive classification. The Missouri Public Service Commission (Commission) issued notice and set an intervention deadline on November 7, 2006.
- 2. Applicant filed an amended application on November 15, 2006 and the Commission granted leave for the amendment, re-issued notice and rest the intervention deadline. No party has intervened.
