

NOTICE OF TERMINATION OF TERRITORIAL AGREEMENT *Records
Public Service Commission*

WHEREAS, the **City of Palmyra, Missouri**, a Municipal Corporation, and **Missouri Rural Electric Cooperative**, a Missouri Rural Electric Cooperative (hereinafter "Cooperative"), entered into a Territorial Agreement dated March 20, 2008; and

WHEREAS, the Missouri Public Service Commission issued its report and order approving said Territorial Agreement, effective June 22, 2008, in Case No. EO-2008-0332; and

WHEREAS, said Territorial Agreement provided that the initial term of the Territorial Agreement shall be for ten (10) years, commencing on the effective date of the order of the Missouri Public Service Commission approving the Territorial Agreement, and shall continue on a year to year basis after the expiration of the initial term, unless terminated in accordance with said Territorial Agreement; and

WHEREAS, said Territorial Agreement further provided that either party to the agreement may terminate the agreement by providing written notice to the other party at least twelve (12) months in advance of the expiration of the initial ten (10) year term or any renewal term of the agreement; and

WHEREAS, said Territorial Agreement further provided that a copy of any notice of termination of the Territorial Agreement shall be simultaneously served upon the Executive Secretary of the Missouri Public Service Commission and the Office of the Public Counsel.

NOW THEREFORE, the City of Palmyra, Missouri, hereby gives written notice of termination of said Territorial Agreement to Cooperative, effective upon the expiration of the initial ten (10) year term of said Territorial Agreement, to-wit: Midnight, June 21, 2018.


