ORDER DIRECTING NOTICE AND SETTING DATE FOR SUBMISSION
OF INTERVENTION REQUESTS

On June 30, 2008, Aquila, Inc., d/b/a Aquila Networks–MPS and Aquila Networks–L&P, submitted proposed rate schedules to adjust charges related to Aquila’s approved Fuel Adjustment Clause (FAC). The schedules bear an effective date of September 1, 2008. Aquila states that since its last FAC-related rate increase, fuel and purchased power costs have increased by approximately \$14.4 million for the MPS Division and by approximately \$1.8 million for the L&P Division; however, in accordance with the FAC approved by the Commission, the proposed rate schedules are designed to recover from customers only 95 percent of those cost increases.

The Commission will give notice of the filing of this tariff to the public; to the parties in Aquila’s last general rate case, ER-2007-0004; and to others who may be interested. The Commission will also set a date for the filing of intervention requests.

IT IS ORDERED THAT:

1. The Data Center of the Missouri Public Service Commission shall mail a copy of this notice to the County Commission for each of the counties in Aquila, Inc.'s service area. In addition, the Data Center shall mail a copy of this notice to each party in ER-2007-0004, Aquila, Inc.'s last general rate case.

2. The Information Officer of the Missouri Public Service Commission shall make notice of this order available to the media serving Aquila, Inc.'s service area and to the members of the General Assembly representing Aquila, Inc.'s service area.

3. Any person wishing to intervene in this matter shall file an application to do so no later than July 29, 2008. Such application shall be filed with:
