## **LIST OF EVIDENTIARY HEARING DATES**

**COMES NOW** the Staff of the Missouri Public Service Commission (Staff), by and through the undersigned counsel, and files this *List of Evidentiary Hearing Dates* with the Missouri Public Service Commission (Commission) respectfully stating the following:

- 1. On September 8, 2011, the Commission convened a prehearing conference in this matter.
- 2. During the prehearing conference, Regulatory Law Judge Daniel Jordan requested that counsel for the Staff notify the Commission of whether the parties would continue to need an evidentiary hearing, and if so, provide a list of recommended dates.
- 3. Although the prehearing conference resulted in clarifying discussions between the parties, an evidentiary hearing remains necessary for the resolution of this matter. The Staff requested an extension until September 22, 2011, to submit a list of evidentiary dates, which the Commission granted by Order.
- 4. Mr. Shepherd has proposed a hearing date of September 15, 2012, to allow the accumulation of another year's worth of usage data to support his claim.

- 5. Counsel for KCP&L Greater Missouri Operations Company (GMO or Company) has conveyed to counsel for the Staff that the Company objects to this request, unless Mr. Shepherd dismisses his claim without prejudice and files his Complaint again when he has the information he believes necessary to proceed.
- 6. Counsel for GMO suggests the following evidentiary hearing dates: October 24, 25, or 28, 2011.
- 7. Counsel for the Staff has conveyed this information to Mr. Shepherd by email, but did not receive a response by the time of this filing. Counsel for the Staff states no conflicts for October 25 or 28, 2011, or a date around September 15, 2012, as that is a Saturday.

**WHEREFORE,** the Staff submits this *List of Evidentiary Hearing Dates* for the Commission's information and consideration.
