- 1. My name is Katherine K. Mudge. I am over the age of 21, of sound mind and competent to testify to the matters stated herein. As of December 31, 2014, I was the Vice President Regulatory Affairs & Litigation for MegaPath Corporation ("MegaPath").
- 2. There are certain portions of the Missouri Telecommunications Company or IVoIP Providers 2014 Annual Report that MegaPath considers Highly Confidential, as follows:
 - a. <u>Line count information</u>, as provided on page 4 of the <u>Missouri Telecommunications Company or IVoIP Providers Annual Report</u>. This information has been designated as proprietary by the Missouri Legislature pursuant to Missouri Revised Statute, § 392.550-3(7)(c). Furthermore, MegaPath considers and treats line count information as highly confidential and proprietary and does not make this information publically available in any format. Disclosure of this information to the public or a competitor would cause harm to MegaPath.
 - b. Revenue information, as provided on pages 3 and 5 of the Missouri Telecommunications Company or IVoIP Providers Annual Report. The Missouri Public Service Commission has designated this type of information as confidential pursuant to Missouri Revised Statute, §386.480. Furthermore, MegaPath considers and treats financial revenue information as highly confidential and proprietary and does not make this information publically available in any format. Disclosure of this information to the public or a competitor would cause harm to MegaPath.
- 3. On December 31, 2014 and effective January 1, 2015, MegaPath Corporation sold certain assets of its NetCo Business Unit, including its network and related vendor and ILEC contracts, its wholesale partner business, and certain employees and Direct Access customers to GC Pivotal, LLC d/b/a Global Capacity ("Global Capacity"). MegaPath filed notice of this transaction with the Missouri Public Service Commission on January 8, 2015 and an Order Canceling Certificate and Accompanying Tariff was issued on February 2, 2015, effective February 12, 2015. MegaPath retained its IVoIP Certificate. Effective April 1, 2015, MegaPath sold certain assets of its Managed Services Business Unit to Global Telecom & Technology Americas, Inc. ("GTT"). The remaining Business Unit of MegaPath is now registered to do business under the name of MegaPath CloudCo Services, LLC.
