On July 6, 2021, Cable One VoIP LLC d/b/a Sparklight filed an application for designation as a wireless Eligible Telecommunications Carrier (ETC).¹ The Commission granted Sparklight's request on August 25, 2021. The effective date of that order is September 24, 2021.

On September 20, 2021, Sparklight filed a Motion for Reconsideration and Request to Withdraw Application. Sparklight states it no longer wishes to have ETC designation due to alternative federal funding it will receive. Sparklight asks to withdraw its application.

Commission Rule 20 CSR 4240-2.116 allows an applicant to withdraw an application without leave of the Commission before testimony is filed. That same rule also allows the Commission to grant leave to parties to withdraw their applications. The Commission also has the power to abrogate its own orders.² Because the Commission

has issued an order granting Sparklight relief, the Commission will abrogate its prior order, and will allow Sparklight to withdraw its application.

THE COMMISSION ORDERS THAT:

- 1. The Commission abrogates its August 25, 2021 order in this file.
- 2. Sparklight is granted leave to dismiss its application.
- 3. This order shall become effective when issued.
- 4. This file shall be closed on September 24, 2021.
