**NOTICE OF DISMISSAL**


COME NOW A. Pheonix Dancer, the Complainant in this proceeding, and Union Electric Company d/b/a AmerenUE, the Respondent, and for their Notice of Dismissal state as follows:

1. On May 10, 2004, A. Pheonix Dancer initiated this proceeding by filing a complaint against AmerenUE.
2. Pursuant to the Commission's Order Setting Prehearing Conference and Directing Filing, on September 7, 2004 the parties to this proceeding participated in a prehearing conference, at which all outstanding issues in this proceeding were resolved to the mutual satisfaction of the Complainant and the Respondent.
3. Under the settlement, the outstanding balance on the Complainant's account was reduced from \$291.59 to \$146.50, and electric service was restored to the Complainant's premises. The Complainant paid the \$146.50 balance, and there are no issues remaining between the parties.

WHEREFORE, the Complainant and Respondent respectfully request that the Commission dismiss this proceeding pursuant to 4 CSR 240-2.116 (1).




