AFFIDAVIT OF MARY DAUDELIN

- I, Mary Daudelin, being first duly sworn, state the following:
- 1. I am employed by Charter Communications, Inc. in the position of Director-Regulatory, and am authorized to make the following statements on behalf of Charter FiberLink-Missouri, LLC ("Charter" or "Company") in response to the Commission's Order Directing Filing of April 29, 2005.
- 2. I am familiar with the process that the Company followed in obtaining one block of 1000 numbers for the Wentzville Rate Center and one block of 1000 numbers for the Pacific Rate Center from the Number Pooling Administrator. Because no numbers were available for assignment, two new NXXs were requested from the North American Numbering Plan Administrator by the Number Pooling Administrator to accommodate our request.
- On December 1, 2004, the Company filed two requests with the Pooling Administrator, seeking a block of numbers for both the Wentzville and Pacific Rate Centers. In Attachment 1, the Company requested that it be issued one block of a thousand numbers in the Pacific Rate Center. This can be seen by reviewing Section 1.4 of the Part 1A document. Section 1.4(c) indicates that Charter requested the "0" block of numbers after the "NXX" was assigned, and Section 1.4(e) indicates that Charter will only be keeping the "0" block of numbers, "the remainder of the blocks [which] will be given to the pool." See Part 1A Section 1.4(c), (e), Att. 1.
- 4. The Pooling Administration System responded on December 14, 2004 by advising the Company that it had issued a block of a thousand numbers for the Pacific Rate Center. See Att. 2. This can be seen in the "Part III Response" block, where the Administrator

noted that the NPA-NXX-X assigned to Charter was 636-393-0. The final digit "0" means that Charter will receive numbers in the zero block ranging from 0000 to 0999, or one thousand numbers.

- 5. Similarly, the Company requested on December 1, 2004 that it be issued an initial block of a thousand numbers in the Wentzville Rate Center. See Part 1A Sections 1.4(c), (e), Att. 3.
- 6. The "Part III Response" section of Attachment 4 confirms that a block of one thousand numbers was issued to the Company for the Wentzville center. The Administrator reported that the NPA-NXX-X assigned to Charter was 636-887-0, with the final digit "0" meaning that Charter will receive numbers in the zero block ranging from 0000 to 0999. See Att. 4.
- 7. The "Assigned Blocks" report in Attachment 5, produced by Neustar, the Pooling Administrator, shows on page 4 that Charter was assigned the "0" block of 636-393 for the Pacific Rate Center. It also shows on page 7 that Charter was assigned the "0" block of 636-887 for the Wentzville Rate Center, and that Southwestern Bell Mobile Systems and CenturyTel have, since then, been assigned the "1" and "3" blocks. See Att. 5 at 4, 7. The "Available Blocks" report contained in Attachment 6 shows the remaining nine blocks in the Pacific NXX of 393 and seven blocks in Wentzville NXX of 887 as unassigned. See Att. 6 at 12, 17.
- 8. These attachments confirm that Charter FiberLink-Missouri LLC has possession of one 1000-block of numbers relating to the Wentzville Rate Center and one 1000-block of
