**ORDER REQUESTING ESTIMATED COST OF COMPLIANCE  
RESPONSES**

The Commission opened this file on July 11, 2018, to assist its Staff in its consideration of new and existing rules regarding the treatment of affiliate transactions and HVAC affiliate transactions by and among electrical corporations, gas corporations, heating companies, water corporations with more than 8,000 customers, and sewer corporations with more than 8,000 customers. Staff filed a third draft rule on February 18, 2020, and the Commission allowed interested stakeholders to file comments regarding the costs that may be incurred to comply with the draft rule. Several stakeholders filed comments.

On July 19, 2023, Staff filed a status report indicating that after further review of the stakeholder comments and discussions with the Office of the Public Counsel, Staff prepared the fourth revised draft rules attached to its status report. Staff stated that it believes the fourth draft of the proposed rules is ready for the Commission to begin the formal rulemaking process. However, so that accurate information is used to create the fiscal notes accompanying the rulemaking, Staff requested that the Commission ask for

additional comments regarding cost of compliance with Staff's fourth draft proposed rules.  
The Commission will do so.

**THE COMMISSION ORDERS THAT:**

1. Any stakeholder wishing to offer comments regarding the costs that may be incurred to comply with Staff's draft rule shall do so by September 11, 2023.
2. This order shall be effective when issued.
