**MOTION TO INVITE COMMENTS
REGARDING COSTS OF COMPLIANCE**

COMES NOW the Staff of the Missouri Public Service Commission (“Staff”), and
for its *Motion to Invite Comments Regarding the Costs of Compliance* respectfully states:

1. Section 536.200.2, RSMo requires the Commission to review the fiscal note that arises from the amending and rescinding of the rules in this docket at the end of the first full fiscal year following the amending and rescinding of the rules to determine the accuracy of the fiscal impact stated in the fiscal note.
