Thank you for submitting your 2007 Annual Report to the Missouri Public Service Commission (MoPSC). I have reviewed your report and have found the following omissions / errors:

1. Your response to page 1, question 4, part b, was omitted. The latest case number on file with the MoPSC is **XA-2003-0234**. Please include this information on any future submissions.

The Commission's Data Center recognizes that "the certification date and case number shall be that of the original certification unless a name change, entity change (Corp. to LLC, etc.) or merger/sale has occurred. In those instances, the effective date and case number shall be that of the latest case on file for one of these occurrences." The effective date can be found at the end of the order for the case and is <u>not</u> the date of the order itself. This item is for informational purposes only and **DO(ES) NOT REQUIRE A COMPANY RESPONSE**.

Upon further review of your annual report, I did identify the following item(s) that need(s) to be corrected:

- 1. Maskina Communications, Inc. is not certificated by the Missouri Public Service Commission as a telecommunication service provider. However, Transcom Communications, Inc. is certificated.
- 2. Missouri Jurisdictional Revenues reported on Page 3, Item 11, of this annual report did not match the revenues reported on the Company's 2008 Annual Statement of Revenue as required. Please make the appropriate changes. If you have questions regarding your Annual Statement of Revenue, please contact Helen Davis at 573-751-4274.

I have attempted to contact you via telephone to discuss this matter without success. Therefore, I have conducted extensive research on Transcom Communications, Inc. in an attempt to gain a better understanding of the Company. Based on my research, it appears the Company was purchased from Transcom Holdings, LLC by Maskina AS, a Norway company, and was renamed Maskina Communications, Inc. a wholly owned subsidiary of Maskina Inc. (aka Maskina AS) on December 2, 2004.

My research also indicates that Maskina AS was purchased by Tower PLC, a British holding company, on June 2, 2005 and renamed Vyke AS. [Please see attached research document.] Therefore, the MoPSC Staff is unclear as to the proper name under which the former Transcom Communications, Inc. should be certificated. If Transcom Communications has, in fact, experienced a name change, it will be necessary for the Company to submit a request for name change.
