ORDER CLARIFYING ORDER SETTING PROCEDURAL SCHEDULE

Issue Date: April 27, 2022 Effective Date: April 27, 2022

On April 27, 2022, the Commission issued its order setting the procedural schedule in this matter, directing the parties to file a list of issues, list of witnesses, and order of cross examination no later than June 8, 2022, and establishing the time and date of the evidentiary hearing to be June 29, 2022, at 9:00 a.m. by Webex. On that same date, the Complainant, Ms. Swopshire, filed a motion requesting that the Commission "reconsider its Order that the Hearing be held by telephone Webex rather than by visual Webex on the internet" and requesting that the Commission issue an order regarding the sequence of witnesses at the evidentiary hearing.

Commission hearings by Webex are conducted using an internet application with full audio and video capabilities. As stated in the *Order Setting Procedural Schedule*, the parties should provide both an appropriate email address and/or telephone number so that an "invitation" to the Webex hearing may be sent or telephoned at the time of the hearing. Once an invitation is sent to a party by email, the party should be able to access the full audio and video features of the Webex application. Those who are unable to

access Webex on the internet (for example, if they do not have a computer with broadband access) may call in to the hearing by telephone. Instructions are provided to allow participation in either fashion.

Under 20 CSR 4240-2.110(5), the order of procedure for introducing evidence in all cases, except investigation cases, requires the complainant to open and close, with intervenors following the staff counsel, or his designee, and then the public counsel, unless otherwise agreed to by the parties. The Commission will order the parties to conform to that requirement when filing their list of issues, list of witnesses, and order of cross examination, due to be filed on or before June 8, 2022.

THE COMMISSION ORDERS THAT:

- 1. The list of issues, list of witnesses, and order of cross examination submitted by the parties for the evidentiary hearing in this matter shall conform to the requirements of 20 CSR 4240-2.110(5).
 - 2. This order shall be effective when issued.
