**ORDER GRANTING EXTENSION TO RESPOND
TO MOTION TO DISMISS**

On December 14, 2021, Lindenwood University filed a complaint against Union Electric Company d/b/a Ameren Missouri. On February 14, 2022, Ameren Missouri filed a motion to dismiss. On March 1, 2022, the Commission directed that responses to Ameren Missouri's motion to dismiss were due on or before March 14, 2022.

On March 11, 2022, Lindenwood University requested a two-week extension of time to file a response to the motion to dismiss. Counsel for Lindenwood University stated it has been involved in expedited litigation in circuit court in an unrelated matter. Counsel for Lindenwood University also stated that no other extension would be sought.

The Commission will grant the requested extension, and apply it to all parties wishing to respond to Ameren Missouri's motion to dismiss.

THE COMMISSION ORDERS THAT:

1. The due date for the response(s) to the motion to dismiss of Ameren Missouri is extended to on or before March 28, 2022. No parties are required to respond.

2. This order shall be effective when issued.
