ORDER DIRECTING JOINT PROPOSED SCHEDULE

Issue Date: March 30, 2022

Effective Date: March 30, 2022

On December 20, 2021, Delmar Gardens Enterprises, Inc. (Delmar Gardens) filed a complaint against Union Electric Company d/b/a Ameren Missouri. On February 7, 2022, Ameren Missouri filed its answer and a motion to dismiss. On March 30, 2022, the Commission denied Ameren Missouri’s motion to dismiss. The complaint is now ready to move to resolution. To that end, the Commission will direct the parties to file, jointly if possible, a proposed procedural schedule.

The Commission will not schedule an on-the-record procedural conference; however, the Commission will encourage the parties to meet on their own in an in-person or virtual procedural conference to discuss a schedule and any related issues, if they believe such a conference would be productive. The Commission will task its Staff with the responsibility of coordinating and filing the joint proposed procedural schedule. The Commission directs the parties to include the following in any proposed procedural schedule:

- Submission of a Joint Stipulation of Facts;
- Submission of List of Issues and Order of opening statements, witnesses, and cross-examination, and Position Statements at least one week in advance of the hearing;
- At least one settlement conference;
- Cut-off dates for service of discovery requests and responses;
- Briefing schedule allowing for ten business days for transcript preparation.

Requests for expedited hearing transcripts must be made before the procedural schedule is established.

THE COMMISSION ORDERS THAT:

1. No later than April 21, 2022, the parties shall submit a request for an extension of time or a joint proposed procedural schedule as described in the body of this order.
2. This order shall be effective when issued.
