1 P R O C E E D I N G S

3 JUDGE VOSS: Good morning. We're here
4 for a prehearing conference in Commission Case No.
5 EC-2007-0186 in the matter of the complaint of Erika
6 Bush against Kansas City Power and Light Company. My
7 name is Cheryl Voss. I'm the regulatory law judge
8 assigned to hear this case.

9 We'll begin with entries of appearance
10 beginning with KCPL, the Commission staff, Public
11 Counsel and Ms. Bush, who is currently not with us yet.
12 KCPL?

13 MR. BLANC: My name is Curtis Blanc,
14 B-L-A-N-C, here on behalf of Kansas City Power and
15 Light. My address is 1201 Walnut, Kansas City,
16 Missouri 64106.

17 JUDGE VOSS: Staff of the Commission?

18 MR. BAKER: My name is Blane Baker with
19 the staff of Commission. My address is P.O. Box 360,
20 Jefferson City, Missouri 65102.

21 JUDGE VOSS: Let the record show that
22 the Office of Public Counsel is not present and also to
23 this point, Ms. Bush has not appeared.

24 The primary purpose of a prehearing
25 conference is to let the parties get together and

1 discuss discovery issues. However, that will not be
2 possible without the Complainant being present.
3 Currently the procedural schedule has the 28th of April
4 as the deadline to file a proposed procedural schedule.
5 I will change that instead to a deadline to file either
6 a motion for another prehearing or any motions to
7 dismiss or anything else that needs to be done in the
8 event that Ms. Bush does not contact me and let me know
9 the reason for her failure to appear.

10 Does that sound reasonable to everybody?

11 MR. BAKER: Yes.

12 JUDGE VOSS: Because if you guys can get
13 a hold of Ms. Bush and you want to have a motion to
14 reschedule the prehearing conference or just to
15 schedule a hearing -- does that sound fine with counsel
16 for Kansas City Power and Light?

17 MR. BLANC: Yes, it does, Your Honor.

18 MR. BAKER: The time is now 10:08.

19 JUDGE VOSS: Let the record reflect that
20 it is now 10:08 and Ms. Bush is still not with us. we
21 are going to conclude the on the record portion. I
22 will be available in the event that you need me.
23 However, the court reporter will not be here. So this
24 will concludes the on record portion.
