**NOTICE OF CHANGE APPLICATION AND
NOTICE OF CORRECTIONS**

COMES NOW Southwestern Bell Telephone Company d/b/a AT&T Missouri ("AT&T Missouri"), pursuant to Section 67.2679.6 RSMo 2000 (Cum. Supp. 2007), and for its Notice of Change Application seeking to expand video service to additional areas, states as follows:

1. AT&T Missouri's principal Missouri office is 909 Chestnut Street, One AT&T Center, Room 3520, St. Louis, Missouri 63101.
2. AT&T Missouri seeks a franchise to provide video service in the following additional political subdivisions, which assess the following video service provider fees:

Political Subdivision	Fee Percentage
City of Battlefield	3%
City of Country Life Acres	5%
City of Fremont Hills	0%
City of Hanley Hills	0%
City of Nixa	5%
City of Republic	5%
City of Springfield	5%
City of Vinita Terrace	0%
Christian County	0%
Greene County	5%

3. Attached is an affidavit signed by an officer of AT&T Missouri affirming this request.
4. AT&T Missouri further notifies the Commission that the fee percentage for the City of Grandview has increased to 5% (from 3%, the percentage shown in AT&T Missouri's


October 16, 2007 Application and in the Commission's November 6, 2007 Video Service Authorization).

5. AT&T Missouri also notifies the Commission that Glasgow Village, which was shown as a political subdivision in AT&T Missouri's April 14, 2008 Notice of Change Application and in the Commission's May 2, 2008 Video Service Authorization, is an unincorporated entity located within St. Louis County, not a political subdivision. Since AT&T Missouri has already been authorized to provide video service in St. Louis County (*see*, Video Service Authorization, issued November 6, 2007), the Commission need only remove Glasgow Village from its list reflecting the political subdivisions in which AT&T Missouri has been authorized to provide video service.

WHEREFORE, AT&T Missouri requests that the Commission issue its order granting AT&T Missouri video service authorization for the additional political subdivisions listed above.


1. AT&T Missouri agrees to comply with all applicable federal and state laws and regulations.
