On February 1, 2016, the Missouri Industrial Energy Consumers and 31 other individual customers of Union Electric Company, d/b/a Ameren Missouri (Ameren Missouri) filed a complaint against Ameren Missouri, asking that the company’s rate structure be redesigned to reduce rates for Noranda Aluminum, Inc. On June 1, the complainants filed notice that they are voluntarily dismissing their complaint.

Commission Rule 4 CSR 240-2.116(1) provides that a complainant may dismiss its complaint at any time before prepared testimony has been filed without an order from
