On January 18, 2017, Midwest Energy Consumers Group, Great Plains Energy Incorporated, the Staff of the Missouri Public Service Commission, and the Consumers Council of Missouri (jointly, "Movants") filed a joint motion requesting the Commission cancel the evidentiary hearing/oral arguments scheduled for February 1 and allow the parties to submit a final round of briefs. The Commission issued an order setting a January 23 deadline for the Office of the Public Counsel (OPC) to file a response to the request to cancel the hearing.
