SECOND ORDER SETTING PREHEARING CONFERENCE

Later that day, the Complainant contacted the Staff of the Missouri Public Service Commission (Staff) and also contacted the Regulatory Law Judge the next day. The Regulatory Law Judge has since spoken with the parties about rescheduling the conference and will reset the conference for the time and date set out below.

THE COMMISSION ORDERS THAT:

1. The parties shall appear in person or by telephone at a prehearing conference to be held on September 5, 2017 at 2:00 p.m.
2. The prehearing conference will convene in Room 305 of the Governor Office Building, 200 Madison Street, Jefferson City, Missouri 65102. The building meets accessibility standards required by the Americans with Disabilities Act. Any person who

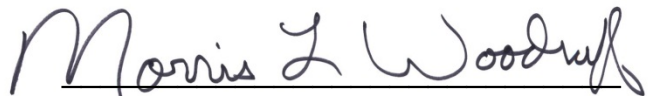
