On April 26, 2017, Jerrald Fisher filed a complaint with the Missouri Public Service Commission ("Commission") against Union Electric Company d/b/a Ameren Missouri ("Ameren Missouri"). On May 30, 2017, Ameren Missouri filed its Answer, Affirmative Defenses and Motion to Dismiss ("Answer") in response to Mr. Fisher's complaint. On June 21, 2017, Ameren Missouri filed a motion for leave to amend its Answer to address additional documents filed by Mr. Fisher and to correct typographical errors.
