Thank you for submitting your 2006 Annual Report to the Missouri Public Service Commission. As a result of my review I have identified the following item(s) that need(s) to be corrected:

1. The company's name was incorrectly listed. The report must include any d/b/a names on each line requesting the company's name. Our records indicate the company's current certificated name is Cause Based Commerce Inc. d/b/a The Sienna Group. The name currently listed on the report will need to be changed to reflect this.
2. The form used was for the 2004 reporting year. As the forms may change, the Commission mails the correct form to the Company each year. The correct form can also be downloaded from our website at [psc.mo.gov](http://psc.mo.gov) and are located under the forms tab on the left hand side of the home page. In addition, an electronic filing may be made by companies that have EFIS access. Generally we do not require resubmission due to the incorrect form being used, but given a resubmission is already required, please submit using the current form. For your convenience I have attached the current form. You will notice two check boxes on the front cover. If the company wishes to have its report filed as highly confidential, please check the non-public box and provide the additional materials required as listed in the cover letter also provided below.

3. A phone number was not provided. This is required for use by the reviewers if there should be a question related to the report.

A response for these items is required in order to show your report as complete and remove it from deficiency status. Pending your response I have provided the Commission's Data Center with a copy of this email to be filed in conjunction with your annual report.

You **must resubmit** the annual report with the appropriate changes to the Data Center as listed below. The resubmission must **include** the number assigned to your report as listed below (BMAR-2007-1419) in order for it to be properly entered into the system.

Your prompt attention to resolving this matter will be appreciated. The Missouri Public Service Commission's rules within chapter 3 of 4 CSR 240 state that a utility company that receives a notice that deficiencies exist in the information provided in the annual report shall respond to that notice within **20 days** or the utility company is subject to a **penalty of \$100** for each day that it is late in filing its response to the deficiency.
