On October 31, 2017, Anthony Granillo filed a formal complaint against Union Electric Company, d/b/a Ameren Missouri ("Ameren"). At Complainant's request, the parties attempted mediation. Mediation complete and the complaint unresolved, the Commission now must determine how to proceed to consider the complaint.
