SUBJECT: Staff Recommendation For **Approval** Of Tariff Sheet To Add The Quarterly Cost

Adjustment For The Fourth Quarter Of 2009 To The Quarterly Cost Adjustment

On January 15, 2010, KCP&L Greater Missouri Operations Company ("GMO") filed with the Commission one (1) tariff sheet bearing an issue date of January 15, 2010, and an effective date of March 1, 2010, to add the quarterly cost adjustment (QCA) for the fourth quarter of 2009. The adjustment is required by GMO's Quarterly Cost Adjustment Rider, which the Commission approved in Case No. HR-2005-0450, and modified in Case No. HR-2009-0092, for steam service after July 1, 2009.

GMO's filing included workpapers consisting of four worksheets showing its calculation of the QCA for the fourth quarter of 2009.

The procedure for the calculation of the QCA for steam service sales occurring after July 1, 2009 is set out in Revised Sheets 6.6 through 6.10 of GMO's tariff, which are entitled, "Quarterly Cost Adjustment Rider – Steam."

Staff reviewed the data and mathematical calculations GMO provided. Staff found GMO's calculations related to the fourth quarter 2009 QCA filing to be correct, and that they satisfy the standards set forth on Revised Sheets 6.6 through 6.10 of GMO's tariff. They are also consistent with previous GMO QCA tariff filings.

Staff has reviewed the proposed tariff sheet, and based on GMO's workpapers, Staff is of the opinion that GMO has calculated the QCA for the fourth quarter of 2009 in accordance with the provisions of GMO's Quarterly Cost Adjustment Rider. Staff therefore recommends that the Commission **approve** the following proposed tariff sheet, as filed on January 15, 2010, to become effective on March 1, 2010, as requested by GMO, or permit the tariff sheet to go into effect on March 1, 2010, by operation-of-law:
