ORDER TO CLARIFY APPLICATION TO PROVIDE INTERCONNECTED VOICE OVER INTERNET PROTOCOL

On October 15, 2018, PD Fiber, LLC, pursuant to Section 392.550, RSMo, filed an application for registration to provide Interconnected Voice over Internet Protocol service. PD Fiber, LLC, in the Affidavit in Exhibit B, proposes to offer "VoIP services *primarily* in Pemiscot, Dunklin and New Madrid counties in Southeast Missouri" (emphasis added). The Commission seeks clarification of the counties or exchanges in which applicant seeks to provide VoIP services due to the use of the modifier "primarily" in its application, which implies that other counties may also be served.

THE COMMISSION ORDERS THAT:

1. PD Fiber, LLC is ordered to respond to the above clarification order no later than October 25, 2018.
2. This order shall be effective when issued.
