On March 29, 2022, PC EXPRESS MO, LLC filed an application seeking registration to provide Interconnected Voice over Internet Protocol service. That application was deficient in that it is not signed by an attorney licensed to practice law in Missouri as required by Commission Rule 20 CSR 4240-28.011(1)(B). The application did not include a copy of the Applicant's Certificate of Registration from the Missouri Secretary of State.

On April 1, 2022, the Commission issued a notice that it would not take action on PC EXPRESS MO, LLC's Application until the described deficiencies were corrected. The deficiencies have not yet been corrected.

The Commission will administratively close this file. This is not a ruling on the merits of the application. The closing of the file does not affect PC EXPRESS MO'S ability to correct the deficiencies in the application in this file. Nor does it affect its ability to file a new application if it chooses to do so.
