On May 12, 2022 Staff filed a motion requesting the Commission to extend the time for filing its recommendation on Starbeam HSI, LLC's application for designation as an Eligible Telecommunications Carrier. Staff's recommendation is currently due on May 14, 2022. In its motion, Staff explains that it submitted data requests to Starbeam on May 12, 2022 to obtain necessary information about its application and responses to those requests are not due until June 1, 2022. Staff requests an extension to June 6, 2022 to file its recommendation. The Commission finds Staff's request for extension reasonable, and will grant it.

THE COMMISSION ORDERS THAT:

1. The Staff Motion to Extend filed on May 12, 2022, is granted. Staff shall file its recommendation no later than June 6, 2022.
2. This order shall be effective when issued.
