2. The pre-filing notice requirements of Commission Rule 20 CSR 4240-4.017(1) are waived.

4. This file shall be closed on July 22, 2023.

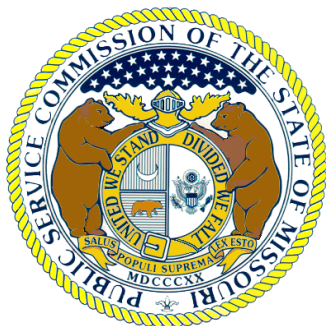
