Dear Ms. Dale:

On August 21, 2003, the Commission issued its Report and Order approving a line certificate for a new AmerenUE transmission line commonly referred to as the Callaway-Franks line. One of the requirements of the Report and Order (see Ordering Paragraph No. 6) was that the Company "survey the transmission line location after construction and record the easement location with the Recorder of Deeds in the appropriate counties [and] ... file a copy of its survey in this case."

After obtaining the certificate, AmerenUE proceeded to obtain the remaining necessary rights-of-way, constructed the line, resolved routine construction damage issues and concluded a handful of condemnation proceedings relating to right-of-way acquisition for the line, and then completed the task of surveying the line, as required by the Report and Order. The final survey work was completed earlier this year and the required recordation in each of the three counties through which the line runs has also now been completed.

In compliance with the Report and Order, AmerenUE hereby submits for filing certified copies of the survey recorded in each of the three counties, and certified copies of an accompanying affidavit that was filed to ensure that the public record was clear and accurate with respect to the properties encumbered by easements relating to this line.

Copies of this filing letter have been served on the Staff of the Commission and the Office of the Public Counsel. Copies of survey and affidavit were not provided to them given the size and voluminous nature of the documents. However, if either Staff or Public Counsel desire that the Company provide them copies, the Company will do so.


