1. I am an attorney with Smith Lewis, LLP, Columbia, Missouri, counsel for Union Electric Company, d/b/a AmerenUE, hereinafter referred to as "AmerenUE", and I have personal knowledge of the facts herein stated.

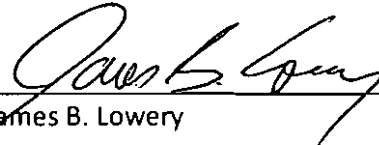
2. Pursuant to certain easement rights, AmerenUE constructed and currently operates a 345 kV electric transmission line in Pulaski, Maries, and Osage Counties, Missouri, hereinafter referred to as "the Callaway-Franks Line".

3. Easement rights were (i) obtained by AmerenUE as the grantee of recorded Transmission Easements granted by various property owners in Pulaski, Maries, and Osage Counties, Missouri; (ii) assigned to AmerenUE as the assignee of recorded Transmission Line Easements granted to Associated Electric Cooperative, Inc. by various property owners in Pulaski, Maries, and Osage Counties, Missouri; and (iii) obtained by AmerenUE through condemnation.

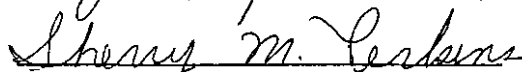
4. Attached as Exhibit A is a schedule of the recording data for the Transmission Easements, Transmission Line Easements, and condemnations.
