On December 2, 2021, Keelee Swopshire ("Complainant") filed a small formal Complaint against Union Electric Company d/b/a Ameren Missouri, and on that date the Commission ordered Staff to investigate and file a report detailing its findings and recommendations no later than January 17, 2022.
