**ORDER GRANTING SECOND EXTENSION OF TIME
TO FILE STAFF REPORT**

On December 2, 2021, Keelee Swopshire (“Complainant”) filed a small formal Complaint against Union Electric Company d/b/a Ameren Missouri, and on that date the Commission ordered Staff to investigate and file a report detailing its findings and recommendations no later than January 17, 2022.

On January 10, 2022, Staff requested a thirty-day extension to the time for filing its report, extending that time to February 16, 2022, which was granted. On February 14, 2022, Staff requested a second extension to the time to file its report, extending that time to no later than April 1, 2022, stating that neither the Complainant nor Ameren Missouri objected to the request.

The Commission finds Staff’s second request for additional time to be reasonable and will grant that request.

THE COMMISSION ORDERS THAT:

1. Staff shall file its report regarding Keelee Swopshire’s small formal

complaint no later than April 1, 2022.

2. This order shall be effective when issued.
