On August 3, 2022,¹ the Missouri Coalition for Fair Competition and Corey Malone filed a complaint against Union Electric Company d/b/a Ameren Missouri. On September 6, Ameren Missouri filed its *Answer, Affirmative Defenses, and Motion to Dismiss*.

On October 21, the Commission issued an *Order Directing Staff to Investigate and File a Report*, directing the Staff of the Commission (Staff) to file a report or request an extension of time no later than November 21.
