ORDER CORRECTING ORDER

Issue Date: August 2, 2023

Effective Date: August 2, 2023

On July 31, the Staff of the Commission (Staff) filed a motion for extension to file its report in this matter, and on August 1, 2023, the Commission issued an order granting an extension to the Staff to complete its investigation and file its report. In the second sentence of its Order, the Commission stated that Staff filed its motion for extension because it required additional time due to Complainant’s sluggish responses to its requests for information. That statement was incorrect, as Staff’s motion actually states: “Staff now requests an extension of time, up to and including August 25, 2023, within which to complete its investigation and file its Report, due to **Respondent’s** sluggish responses to its requests for information.”

The Commission will correct the order accordingly.

THE COMMISSION ORDERS THAT:

1. The second sentence of the Commission’s *Order Granting Extension* is corrected to read: “On July 31, 2023, the Staff of the Commission (Staff) filed a motion for extension of time to file its report, explaining that it requires additional time to complete

its investigation and file its report due to Respondent's sluggish responses to its requests for information."

2. This order shall be effective when issued.
