ORDER DIRECTING STAFF TO FILE RECOMMENDATION ON FINANCING COMPLIANCE

On March 9, 2022, the Commission issued an *Order Approving Application for Financing Authority ("Order")*, subject to enumerated conditions, effective March 19, 2022.

On April 29, 2022, Ameren Missouri filed a *Notice of Filing Compliance Items* in which it informed the Commission that it had completed the financing approved by the *Order* and was filing items in compliance with the conditions of the *Order*.

The Commission will ask its Staff to file a recommendation advising the Commission as to whether the submitted items comply with the *Order* and, if so, whether the file in this matter is ready to be closed.

THE COMMISSION ORDERS THAT:

1. No later than May 13, 2022, Staff shall file a recommendation as to whether the information in the *Notice of Filing Compliance Items* and the accompanying attachments comply with the Commission's *Order*.

2. No later than May 13, 2022, Staff shall inform the Commission as to whether the file in this matter is ready to be closed.

3. This order shall be effective when issued.
