Therefore, we submit this report pursuant to the rules cited above. This will ensure that any party to this case will have notice of the attached information and a full and fair opportunity to respond to the comments contained therein.

Mr. Davis, allow me to introduce myself, I'm Terry L. Silvey and I am the Mayor of The City of Versailles. I wish to share some thoughts with you and your Commission about the recent ice storm damage and issues our City incurred in December 2007. Our City was hit hard by the ice storm, causing a large amount of debris damage, down power lines, the loss of electric service to residents; it was probably the worse situation our City had ever dealt with before. We have about 1,100 residential households with a City population of Two Thousand Six Hundred. Most of our City was without electric service, at times as many as 800 households were affected. I have to say and share that AmerenUE in my opinion and most of our City's residents feel that they did a terrific job, they were courteous, they sent a large volume of trucks and service people and they worked in extremely difficult surroundings and made every attempt to restore power as quickly, efficiently, and professionally as they could.
