**MOTION FOR EXTENSION OF TIME
TO FILE STAFF RECOMMENDATION**

COMES NOW the Staff of the Missouri Public Service Commission and, for its Motion for Extension of Time to File Staff Recommendation, states to the Missouri Public Service Commission as follows:

1. On August 29, 2006, Applicants City of Centralia, Missouri, and Boone County Water District No. 10 initiated this case by filing their Joint Application for Approval of a second amendment to a written territorial agreement. On August 30, 2006, the Commission ordered the Staff to file its recommendation regarding the said joint application by no later than September 29, 2006.

2. Due to the press of other business, specifically including the resolution of the rate cases files by Aqua Missouri and its affiliates, the prehearing conference for the Central Jefferson County Utility Company's asset transfer case, the filing of a stipulation in a Lake Region Water and Sewer Company certificate case, and preparation for a circuit court trial in a case involving Osage Water Company, neither the Staff nor the General Counsel's Office has been able to complete work on the preparation of the Staff Recommendation for this case.

3. The Staff therefore requests that the deadline for filing the Staff Recommendation in this case be extended by two business days, to October 3, 2005.

4. This short delay in the filing of the Staff Recommendation will not prejudice any party to this case.

5. Commission Rule 4 CSR 240-2.050 (3) (A) authorizes the Commission, at its discretion, to enlarge the period of time allowed by a previous order for a party to do an act.

WHEREFORE, the Staff respectfully moves the Commission for its order extending the time for filing the Staff Recommendation in this case, by two business days, to 5:00 p.m. on October 3, 2006.
