Mrs. Donald Chandler was very angry because power was off part about  $2\frac{1}{2}$  hours today and when she called ~~it~~ it in they were rude to her and totally exaggerated the time it <sup>was</sup> off. They had to close their saw-mill down for the day and send their workers home at 8:30 or so and then the power came back on about 11:00 AM.

A lot of the people I talked to were angry because they lost frozen food & food when the power was off so long.

Roger Price Called AmerenUE July 19, 20, 21 + 22. to report trees over electric lines close to his house. Ameren said his report was never documented till Sat. July 22. When the electric was turned back on, the downed electric wires caused a fire, in which, he had to call the fire department.

Charles & Rick Freeman owners of American Customer Service Co. of Black, MO. They operate a vending business & had their electric off from July 19-24. loosing thousands of dollars worth of frozen foods. Due to the power surge Rick Freeman lost an electric furnace, Air Conditioner, dish washer, 2 televisions, lamps and central vacuum system.

When our electric was restored, it was Black River Electric Corp. that did the job for AmerenUE who said they were under staffed and didn't know the area that well.
