Dear Ms. Dale:

On December 27, 2006, The Empire District Electric Company ("Empire") caused to be filed with the Missouri Public Service Commission ("Commission") certain revised tariff sheets in electronic format and a Motion for Expedited Consideration and Approval of Tariff Sheets filed in Compliance with Commission Order on Less than Thirty Days Notice ("Motion"). The revised tariff sheets were identified in a transmittal letter dated December 27, 2006. Empire hereby withdraws said revised tariff sheets and Motion.

Enclosed for filing with the Commission on behalf of Empire, please find in electronic format certain revised tariff sheets. These tariff sheets are being filed to comply with the Commission's Report and Order issued in Case No. ER-2006-0315 on December 21, 2006 and effective December 31, 2006. The revised tariff sheets are designed to produce an increase in Empire's gross annual electric revenues of \$29,369,397, excluding gross receipt taxes, fees or other similar fees or taxes.

The revised tariff sheets being filed herewith are listed below. Each bears an issue date of December 28, 2006, and a proposed effective date of January 27, 2007. Empire, however, requests that the revised tariff sheets be permitted to take effect for service rendered on and after January 1, 2007, for good cause shown, all as explained in greater detail in the Motion for Expedited Consideration and Approval of Tariff Sheets filed in Compliance with Commission Order on Less than Thirty Days Notice which is also being filed herewith in electronic format.


