On November 12, 2012, Missouri Gas Energy (MGE or Company), a division of Southern Union Company, filed an Application (Application) with the Missouri Public Service Commission (Commission), requesting that the Commission grant MGE a certificate of public convenience and necessity (CCN) authorizing it to construct, install, own, operate, control, manage and maintain a natural gas distribution system to provide gas service in Lawrence County (Section 24, Township 28 North, Range 27 West and Section 19, Township 28 North, Range 26 West), Missouri, as an expansion of its existing certificated area. On January 9, 2013, the Commission issued an Order_granting that CCN. On January 10, 2013, the Company filed two tariff sheets bearing an effective date of February 9, 2013, reflecting the Commission's granting of the CCN request.

The Commission's Energy Rate Design & Tariff Staff (Staff) has reviewed those tariff sheets and believes they comply with the Commission's Order; therefore, Staff recommends that the Commission approve the tariff sheets, or, in the alternative, allow these tariff sheets to go into effect by operation of law.

The Staff has verified that this company has filed its annual report and is not delinquent on any assessment. Staff is not aware of any other matter before the Commission that affects, or is affected by, this filing.
