DIECA Communications, Inc. d/b/a Covad Communications Company ("Covad") did not impose the Relay Missouri Surcharge in 2008. Covad's VoIP Registration (and the implementing legislation, HB 1779) was not effective until August 28, 2008. The MPSC did not establish a rule that required and/or identified the basis for implementation of the TRS on Missouri intrastate VoIP traffic in 2008. The MPSC approved a rule implementing HB 1779 in February 2009 and the rule is effective April 15, 2009, at which time, Covad will begin imposition, collection, and remittance of the TRS Surcharge on its Missouri intrastate VoIP revenues.



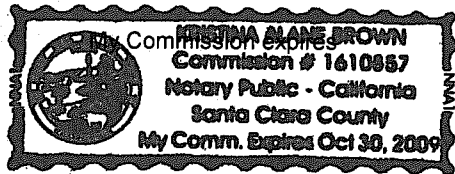


